# **Recognition of Foreign Seafarer Certificates of Competency in Terms of the STCW Convention**

TO OWNERS, OPERATORS AND MASTERS OF SOUTH AFRICAN SHIPS (OTHER THAN FISHING VESSELS), FOREIGN CERTIFICATION HOLDERS, MANNING AGENCIES, PRINCIPAL OFFICERS AND EXAMINERS

Marine Notice no 22 of 2015 is hereby cancelled

#### **Summary**

This Marine Notice lists countries which South Africa, through SAMSA has entered into agreement with, to recognise Certificates of Competency issued by foreign administrations in accordance with Regulation I/10 of the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978, as amended. This is in accordance with Regulation 98 of the Merchant Shipping (Safe Manning, Training and Certification) Regulations, 2013, as amended.
